- 1. The contestant must reside in Los Alamos or be part of a Los Alamos youth organization such as Los Alamos Grange, Los Alamos Based Travel Sports Club, or District 7 Jr. High Rodeo and be enrolled in Grades 5th-8th grade.**
- 2. The Princess will be named during the Los Alamos Men's Club General Membership Meeting on 9/17/26 . Time to be determined.**
- 3. The number of contestants allowed to participate in the contest will be determined at the time of registration. The participant slots will be awarded to contestants who turn the application for Princess between the dates of 5/1/26 and 6/30/26. All applications must be received by midnight 6/30/26. In person or E Mailed to SRW72478@aol.com.**
- 4. Each contestant will be judged on community service activities and the total amount raised. Community Service will account for 25% of their score, Money raised will account for 75% of the total score.**
- 5. Each contestant must meet the \$500 minimum of money raised from the Raffle Tickets in order to qualify for a title. Each contestant/legal guardian will be responsible for the tickets and money raised. The contestant must turn in all unsold raffle tickets and money collected on 9/13/26 by 5pm.**
- 6. The Princess will receive a scholarship of \$300 , 1st runner up \$200, 2nd runner up \$100 to further education, pay sport fees, sport /church camps or livestock expenses. The scholarship will be paid in one lump sum.**
- 7. Contestants will not hold the Los Alamos Men's Club . Board of Directors, or Queen /Princess Committee members liable of any accident or injury that may or might occur as a result of the contest or future obligations. A parental rule agreement and liability release form must be signed and submitted with the contest application.**

8. Ties will not be allowed in the contest. In the event of a tie the place will be awarded to the contestant with the highest amount of community service hours. If there is tie in community service hours the committee will review the scores with the judges.
9. The Princess , 1st runner-up and 2nd runner -up will be required to volunteer time during Old Days 9/25/26-9/27/26.
